136. PLANNING

136.1 To consider the following planning applications:

**18/504312 Land Rear of Barker Cottages, New Cut**

Minor Material Amendment to condition 15 of application 15/504242 (Erection of single storey dwelling (revised scheme)). To amend the internal floor layout and external elevations to allow for additional windows and revised window sizes to some elevations, new gable effect detail to the front elevation and repositioning of the timber loading style door. To provide limestone to the west and south elevations only with the north and east elevations being in brickwork.

The Planning Committee AGREED unanimously that it wished to see this application APPROVED. It was AGREED that members and residents local to the property would monitor the works.

**18/504797 2 River Close, East Farleigh ME15 0JE**

Erection of a rear and side single storey extension.

The Planning Committee AGREED unanimously that it wished to see this application APPROVED.
