Conversion of existing annex within property to holiday let (part retrospective) The Planning Committee AGREED unanimously that it wished to see this application APPROVED.

18/504312 Land Rear of Barker Cottages, New Cut

Minor Material Amendment to condition 15 of application 15/504242 (Erection of single storey dwelling (revised scheme)). To amend the internal floor layout and external elevations to allow for additional windows and revised window sizes to some elevations, new gable effect detail to the front elevation and repositioning of the timber loading style door. To provide limestone to the west and south elevations only with the north and east elevations being in brickwork.
